Application for Specific Use Permit	\$150.00	To allow certain uses within base Zoning districts that, under most circumstances, would not be compatible with other permitted uses but with certain conditions and development restrictions may be compatible.
Application for Variance	\$100.00	
Amended Plat	\$100.00	A revised plat correcting errors or making minor changes to the original recorded final plat.
Plat	\$250.00	For a new Subdivision or large scale development
Re-plat	\$150.00	The re-subdividing of any part or all of a block or blocks of a previously platted subdivision, additional lot or tract.
Minor Plat	\$100.00	A subdivision resulting in four or fewer lots, provided that the plat is for conveyance purposes only (i.e., sale of the property with no development/construction proposed), that the plat does not create any new easements for public facilities, or the construction/development of said subdivision will not require that construction of any new street (or portion thereof) or the extension of any municipal facilities to serve any lot within the subdivision. Any property to be subdivided using a minor plat shall already be served by all required City utilities and services or in the ETJ of the City of Van with all City utilities and services.
